- b. Directors' General Comments: None.
- c. General Manager's Report: In addition to the written report, Mr. Jaggers reported:
 - Annual Encroachment Permit: The District has made the payment for an annual encroachment permit from the City of Beaumont, streamlining the process for infrastructure work. More than 40 previous pavement patches will be covered under the modified standards, resulting in a significant cost savings from around \$600,000 to approximately \$100,000.
 - Elm Street Pipeline Project Completion: The Elm Street pipeline project is fully completed, with two new fire hydrants installed and the street repaved, providing enhanced infrastructure for the area.
 - 12th and Palm Facility Renovations: Progress on the 12th and Palm facility includes drywall installation, taping, and preparation for interior layout. A bathroom was added. Furniture has been ordered. The space is being configured to support training and workspace needs efficiently and costeffectively, avoiding significant expenditures on modular buildings.
 - Grant for Relocating Well 30: Staff is preparing a grant application to support relocating Well 30 from Noble Creek Park to a site near the recharge facility, addressing operational concerns.
 - Cybersecurity Grant Application: The district has applied for a \$250,000 grant to enhance cybersecurity infrastructure.
 - B-Line ARPA Project Bids: Bids for the ARPA-funded B-line project were recently opened, with plans to present the selected bid for Board approval soon.

President Covington added that the district achieved its fourth consecutive year as a certified Great Place to Work, reflecting a collaborative environment among the Board, management, and staff.
