Overview

As of the preparation of this report (4/23/2025), the District has received **27 formal written protests** (designated P01–P27) submitted by property owners and customers in response to the Proposition 218 notice mailed in March 2025. The majority of these letters express **opposition to the proposed rate structure**, particularly the **multi-year increase in both volumetric and fixed charges**.

These themes were similar to those provided in the AB 2257 Challenge Letters.

• Summary of Protest Themes

1. Perceived Excessiveness of Rate Increases

- Many letters describe the increases as "exorbitant" or "unreasonable," especially given the cumulative effect over five years.
- Concerns were expressed about bi-monthly bills **doubling or more** when combining base charges with SCE and SWP pass-throughs.

2. Impact on Seniors and Fixed-Income Households

- The most prevalent concern.
- Writers express fear of **not affording medication**, **groceries**, **or housing costs** due to rising water bills.
- Residents cite Social Security as their only income, making increases difficult to absorb.

3. Disproportionate Effect on Low-Use Customers

• Several customers who conserve water expressed frustration that increased **fixed charges** penalize them despite low usage.

4. General Inflation and Financial Pressure

• Writers note that the proposed rate hikes come amid elevated costs for **housing**, **food**, **gasoline**, **electricity**, **and HOA fees**, compounding the hardship.

5. Allegations of Salary Increases for Management and Board

- Letters reference alleged **40–60% salary raises** approved in prior years.
- Perception that these increases were excessive and poorly timed given economic conditions.

6. Lack of Transparency and Public Involvement

- The community was **not adequately consulted**
- Financial decisions appear to be **predetermined**
- Details regarding rate calculation and expenditures are **not easily accessible**

7. Calls for Delay or Alternatives

- Pausing the rate increases
- Performing an independent audit
- Exploring grants or state/federal funding
- Assessing whether **new developments** are contributing fairly

8. Water Quality Complaints

• One protest cited **hard water** damaging pipes and appliances, questioning the justification for increasing rates when **service quality is perceived as low**.

9. Business and Rental Property Concerns

- Small business owners and landlords expressed concern that increased utility costs will:
 - Be passed on to tenants
 - Undermine profitability
 - Threaten business sustainability

10. Billing Structure Confusion

• One letter challenged the complexity of the current tiered billing system and recent changes to how usage is calculated.

11. Emotional and Human Impact

- Some letters describe the impact in personal terms:
 - o "Will I have to choose between water and my heart medicine?"
 - o "How can a senior on \$1,300/month afford this?"

12. General Disapproval Without Detail

• Several protests fulfilled the legal requirements under Proposition 218 but offered minimal explanation beyond expressing objection.

My name is Doris Foreman. I reside at 1781 Desert Poppy Lane in Beaumont. I wish to Protest the proposed rate height. I live on my Social Security check which I hope I continue to receive. I live on a fixed income. I try to keep my water bill down and take many measures to prevent the loss of water.

The thought that no matter how I try to save water, my bill will be going from a base of \$29.63 to \$59.63 in five years is anxiety producing. With the addition of Tier I, SWP and SCE charges, I am paying \$59.83 for a meter usage of 160. This means that I will be paying close to \$100 for water. PROTEST: Proposed Changes to Water Rates and Service Charges

This is to <u>Protest</u> the pending subject changes to be heard at the upcoming Public Hearing scheduled for April 24, 2025.

The proposed increases are way in excess of any reasonable ongoing amount in residential water billings, more than DOUBLING in 5 years. While the sixth page of the Notice of Public Hearing recently distributed seeks to characterize the proposed increases as minimal, citing a \$15.97 increase in the first year, this is a 17% increase over the cited "Estimated Bill" of \$93.17 in the Notice. Further, this "Estimated Bill" over a two-month period seems unreasonably low. Our last two bills have averaged \$168 during the winter, meaning our first year bi-monthly bill increase will be nearly \$29. While it is not immediately clear from the information provided, as to the exact components of the \$15.97 first year increase, the resulting 17% change, if compounded over the proposed 5 year period, will increase our average winter bill by 119%, or to \$368. In addition, even more increased costs will need to be passed through to us by added cHomeowners A³² Association fees for their increased water costs.

By any measure, the proposed increases are exorbitant, to say the least. Our country's Federal Reserve has been struggling for months to bring the national inflation rate from nearly 3% down to 2%. It is increases like the proposed that militate against their efforts to keep our cost-of-living from spiraling out-of-control. Who among us has income that is increasing by 17% annually? Especially in a community like Four Seasons, where many are retired, and some on relatively fixed incomes?

The Notice attempts to allay our concerns on the third page by stating that BCVWD is not legally allowed to make a "profit". All this limit does for governmental agencies is to provide a strong incentive to spend every dollar taken in to avoid such a profit. In the same page, it states that any excess revenues realized over those expended will be added to BCVWD's reserves, instead of used to reduce their billing rates to their users. Accordingly, I hereby strongly protest the proposed rate increases and encourage the BCVWD to reconsider them in lieu of something much more reasonable.

I am writing to express concern on behalf of myself and my neighbors regarding the Beaumont-Cherry Valley Water District's recent and proposed water rate hikes of approximately 20% per year for the next 5 years. These increases are significant and unwarranted.

Recently, salary raises, ranging from 40% to 60%, and your expensive equipment purchases were approved without community input, imposing substantial financial burdens on our city and businesses. With high property taxes and increasing utility costs, the proposed rate hike will add to these expenses already overwhelming our city.
